

# St. Vrain Flooding Relief Fund Grant Program Guidelines

The St. Vrain Flooding Relief Fund is designed to provide financial resources to charitable organizations that are involved in the relief and rebuilding efforts in the St. Vrain Valley related to the September 2013 flood.

A selection committee will review each request and will make recommendations quickly. We're grateful for the overwhelming support by individuals, families and businesses in our community that have allowed us to distribute these emergency funds to the community.

### Availability of Funds: Immediate

### What activities are eligible for funding?

Immediate Relief and Future Activities related to the flooding event in September 2013. 100% of ALL funds raised by the St. Vrain Flooding Relief Fund will be expended.

#### Who may apply?

Organizations within the St. Vrain Valley School District with a designated 501(c)(3) nonprofit status under the Internal Revenue Code; includes religious organizations, schools and public programs. Organizations that receive grants must expend their grant dollars within 6 months unless request for additional time is made in application. You may call us to see if your organization qualifies for a grant

#### What we will fund:

- **Immediate activities**. Those organizations that became involved in helping with the crisis and utilize their day-to-day resources (e.g. funding/volunteers) to help with activities related to the crisis (e.g. sheltering displaced individuals/families, feeding displaced individuals/families, sheltering animals, etc).
- **Future projects** related to clean up and rebuilding of the St. Vrain Valley (e.g. repair of homes, repair of community resources; other projects that directly impact recovery and health of the community and its residents)

#### What we will not fund

- Activities not related to the September 2013 Flood event
- Endowments, annual campaigns
- Loans, scholarships, fellowships, honorary awards, or travel grants
- Multi-year requests
- Requests from individuals
- Requests that further a political doctrine or religious activity

#### When and how should I apply?

- The Longmont Community Foundation will accept St. Vrain Flooding Relief Requests starting September 24, 2013. Grant requests will be considered until funds are expended. NOTE: There might be additional funding opportunities once this first phase of funding is completed.
- Notification of grant approval will take approximately two-weeks
