# noosa's Ultimate Flavor Finder Contest Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. Purchase and Non-Purchase entries have an equal chance of winning. VOID WHERE PROHIBITED BY LAW OR REGULATION. You must be twenty-one (21) years of age or older to enter and or to vote in this Contest Open to legal residents of the United States and the District of Columbia (excluding Puerto Rico, U.S. Virgin Islands and Guam) at the time of entry.

- 1. CONTEST TIMING: The noosa Ultimate Flavor Finder Contest (the "Contest") entry period begins on Wednesday, April 4, 2018 at 12:00:01 a.m. Eastern Daylight Time ("EDT") and ends on Friday, April 20, 2018 at 11:59:59 p.m. EDT (the "Entry Period"). All eligible entries will be reviewed for compliance with these Official Rules ("Official Rules") and, if compliant, will be made available for Judging. All entries will be judged based on pre-defined criteria (as later described in these Official Rules), by a panel of judges selected by the Sponsor at its sole discretion, to determine four (4) prize winning entries plus three (3) alternates which public voting will determine one (1) winner. The public voting period will begin on Saturday, April 28, 2018 at 12:01:00 EDT and end on Monday, April 30, 2018 at 11:59:59 p.m. EDT (the "Voting Period"). At the conclusion of the Voting Period the one (1) entry with the greatest number of votes will become the fifth (5) prize winner. Entry in the Contest does not constitute entry into any other promotion, contest or sweepstakes. By participating in the Contest, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of noosa Yoghurt, LLC, The Village at Flatirons Crossing, 1 West Flatirons Crossing Drive, #416, Broomfield, CO 80021 (the "Sponsor"), and/or WYNG, 360 Park Avenue S., 20th Floor, NY, NY 10010 (the "Administrator") whose decisions shall be final and legally binding in all respects and not subject to further review in any forum.

#### **Entry Notes:**

Each potential Finalist will be notified via direct message or email and will be required to confirm eligibility (home mailing address and birthdate) as well as agree to meet with Administrator for a brief video call within twenty-four (24) hours from the time and date notice is sent in order to proceed in the Contest.   - 33% Caption Contest (did the Entrant demonstrate that they are a true food lover that wants to scour the world for interesting flavors?)
  - 33% Photo Originality
  - 34% Taste Bud Appeal (Is the creation mouthwatering, delicious and palatable?)

The four (4) entries with the highest judges' score will be deemed the first four (4) winning entries. The fifth winning entry will be determined by public voting. In the event of a tie, a third-party judge selected by the Sponsor, will cast one vote between the tied entries to determine the winning entry.

Sponsor receives the right to select fewer than four finalists, if in its sole discretion, it does not receive a sufficient number of eligible & qualified submissions.

- <u>5.</u> <u>VOTING:</u> The Sponsor will post three (3) potential winning entries to the voting site. When participating in the Public Voting, please use the judging criteria in Rule #4 above to cast your vote.
- 6. PUBLIC VOTING: The three (3) potential winning Eligible Entries will be posted to the gallery page located at <a href="www.noosayoghurt.com/flavorfinder">www.noosayoghurt.com/flavorfinder</a> during the Voting Period. The Voting Period will begin on Saturday, April 28, 2018 at 12:01:00 EDT and end on Monday, April 30, 2018 at 11:59:59 p.m. EDT. At the conclusion of the Voting Period, the entry with the greatest number of fan votes will become the fifth winning entry. In the event of a tie, a third-party judge selected by the Sponsor will cast one vote between the tied entries to determine the winner.

LIMIT: You may vote one time per calendar day ET.

<u>VINNER ANNOUNCEMENT</u>: All five (5) winning entries will be announced on or about Monday, May 7, 2018.
