LOCAL LAW FILING COUNTY OF YATES

LOCAL LAW 1-18 ENTITLED: PROHIBITING THE USE OF TOBACCO, NICOTINE, OR OTHER LIKE SUBSTANCES UPON REAL PROPERTY & VEHICLES OWNED OR LEASED BY THE COUNTY OF YATES

Be it enacted by the Legislature of the County of Yates as follows:

Section 1: Findings

The Legislature of the County of Yates finds that the use of tobacco, nicotine, or other like substances on real

tract language. H. Nothing in this Local Law shall create a right of action in any person against the County or its agents to compel enforce-ment of this Local Law against private parties

Section 8: Other Applicable Laws

This Local Law shall not be interpreted or construed to per-mit tobacco, nicotine, or other like substances use where it is otherwise restricted by other applicable laws.

Section 9: Severability
